- 1. Continuation of Ban on Private Practice:** The prohibition on engaging in any form of private practice by Dr. Younis Kamal, Associate Professor, Department of Orthopedics, Government Medical College, Anantnag, shall continue to remain in force until further orders from the Government.
- 2. Monitoring of Attendance and Duty Hours:** The Nodal Officer, AEBAS (Biometric Attendance System), Government Medical College, Anantnag, shall ensure strict monitoring of attendance and adherence to prescribed duty hours by the officer concerned. The Nodal Officer shall maintain complete biometric attendance records and furnish monthly attendance reports to this office regularly without fail.

Medical College, Anantnag, shall closely monitor the professional performance, conduct, devotion to duty and adherence to service conduct rules by the officer concerned and shall submit monthly performance reports to this office through Medical Superintendent, MMABM Associated Hospital, Government Medical College, Anantnag, for a period of six (06) months from the date of issuance of the aforesaid Government Order.

Any deviation from or violation of these instructions shall be viewed seriously and shall be reported to the Competent Authority for initiation of appropriate disciplinary action under rules.
