Subject: Provisional Selection list of left over seats in B.Sc. Nursing Course at Govt. Nursing College, GMC Anantnag.

Whereas, vide J&K Nursing Council Notification No. JKNC-25/157/2997-3005 dated 08-10-2025, the institution was directed to complete the admission process for the left-over seats in the B.Sc. Nursing Course;

Whereas, Govt. Medical College, Anantnag issued Admission Notification No. GMCA/P/Nur/2025/1141-50 dated 15-10-2025 inviting applications for filling up two (02) Open Merit seats in the B.Sc. Nursing Course. During the admission process, two additional Open Merit candidates vacated their seats prior to issuance of the final selection list. Accordingly, these seats were included under left-over seats and a selection list for four (04) seats was issued vide No. GMCA/P/Nur/2025/1222-26 dated 30-10-2025, against which all four seats were filled;

Whereas, subsequently, the J&K Nursing Council extended the date for submission of the final admission list up to 30th November 2025 vide Notification No. JKNC/ADMISSION/2025-26/115/3121-3128. After issuance of the 1st selection list, two additional Open Merit candidates vacated their seats prior to the final submission date, and the same were filled vide Notification No. GMCA: P/Nur/2025/1441-1451 dated 24-11-2025. Out of these two seats, one candidate subsequently cancelled his/her admission, thereby resulting in one (01) vacant seat in the Open Merit category.

Whereas, the J&K Nursing Council has further extended the date for completion of admission against left-over seats up to 31st December 2025 vide Notification No. JKNC-25/157/3628-31. As only one day was available for completion of admission and the merit list of Open Merit candidates was already available with the institution, the same was operated accordingly. The next eligible Open Merit candidate was contacted and asked to submit willingness to take up the said left-over seat;

Now, therefore, the Provisional Selection List of candidate(s) for one (01) left-over seat in the Open Merit category in the B.Sc. Nursing Course at Government Nursing College, GMC Anantnag is hereby notified and annexed as Annexure-A.

1. The fulfilment of eligibility criteria has been determined by the J&K Nursing Council vide Notification No. JKNC-25/157/2997-3005 Dated: 08-10-2025 and JKBOPEE Notification No. 031-BOPEE of 2025 Dated: 17-03-2025.
2. The selection is purely on provisional and provisionally selected candidates are required to produce all relevant original documents (Marks card, Domicile Certificate, Provisional-cum-Character Certificate, Category Certificate) in the Office of Govt. Nursing College, GMC Anantnag by or before **31-12-2025 (up to 4:30 PM)**.
3. The Admission Form, along with the required Affidavit(s) and Medical Fitness Certificate, is available on the official website: www.gmcanantnag.ac.in. The selected candidates must bring all required documents along with a **Demand Draft of ₹9100/-** drawn in favour of *Principal, College of Nursing and Paramedical Sciences, GMC Anantnag*.
4. If the provisionally selected candidate fails to attend and submit the required original documents within the stipulated time, his/her provisional selection shall stand cancelled automatically.
5. The candidate is directed to complete the admission process on 31st December 2025 by 4:30 PM, failing which the candidature shall stand cancelled automatically, as no admission beyond this date shall be entertained by the Indian Nursing Council (INC), as mentioned in Notification No. JKNC-25/157/3628-31 dated 30-12-2025
