



**Terms and Conditions:**

1. The above candidate shall have to execute an agreement with the institution on a prescribed format (**Form A of S.O 364**) with regard to the various terms and conditions applicable during academic arrangement. The candidate shall strictly ensure that he/she shall not leave the post (College) before the completion of tenure of six months, however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side falling which the salary shall not be paid for one month to the incumbent which shall be released on completion of stipulated sanctioned term.
2. Before joining the Department, the selected candidate shall submit an affidavit in the office of the Administrative Officer, Govt. Medical College Anantnag duly attested by the Judicial Magistrate(**1<sup>st</sup> Class**) to the effect that:
  - a. I understand all the terms and conditions set out in the agreement (Form A of S.O 364 of 2020) and I shall be bound by all such terms and conditions (Form A of S.O 364) duly executed by me.
  - b. If any of the information furnished by me to the college is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
  - c. I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - d. I shall remain disciplined during the tenure period; any kind of misconduct shall make me liable for termination without any prior notice.
  - e. I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
  - f. I shall not claim any Experience Certificate in case I leave Junior Resident-ship before completion of first six months.
  - g. I will not indulge in any private practice. In case I am found doing private practice my appointment shall be liable for termination without any notice.
