The above appointment shall be subjected to the fulfilment of following terms and conditions: -

- 1. The appointee is directed to join GMC Anantnag at office of the Principal, Main Campus Dialgam within a period of 21 days from the date of publication of this appointment order and shall be allowed to join on production of the following documents/testimonials in original for verification.
- i) Domicile Certificate.
- ii) Date of Birth Certificate.
- iii) Qualification Certificate(s).
- iv) Category Certificate (if any).
- v) Physical Fitness Certificate.
- 2. That if the appointee has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and stakes, if any, in such self-employment unit/enterprise before joining the Government services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and personally monitor its recovery.
- 3. The appointment shall be deemed to be cancelled Ab-initio, if at any stage it emerges that the certificates/testimonials produced by the candidate is/are fake or forged and legal action under relevant section of law may also be initiated against appointee.
- 4. The salary of the appointee shall not be drawn and disbursed unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate (if any) is received from the concerned Authorities/Agencies.
- 5. The seniority of the appointee shall be regulated under J&K Civil services (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by the appointee in the final selection list issued by JKSSB.
